

Presentation

This document includes the activities carried out by the Quality Assurance Agency for Higher Education of Andorra (Agència de Qualitat de l'Ensenyament Superior d'Andorra — AQUA) during 2022.

The year 2022 has witnesses what, for many, is the end of the pandemic that began in early 2020 due to COVID-19. The pandemic affected all sectors of society, including higher education. Once overcome, AQUA has observed the resumption of activities in higher education institutions.

The year 2022 has been marked by a significant increase in the creation of official degrees. This is primarily attributed to the consolidation of private higher education institutions established in Andorra. In this regard, one of the highlights has been the publication of Decree 183/2022, of 4 May 2022, approving the regulation for the authorization of universities and other private higher education institutions in the Andorran higher education system (and its modification: Decree 209/2022, of 18 May 2022) which aims to regulate the establishment of new higher education institutions into Andorra.

Regarding the internal structure of AQUA, the year 2022 has been characterized by the approval of Decree 68/2022, of 23 February 2022, approving the amendment of the regulation of the Quality Assurance Agency for Higher Education of Andorra (AQUA). Additionally, the year 2022 has been marked by the maternity leave of the director of AQUA, leading to the appointment of a substitute director. This decision was communicated through an official notice on 21 February 2022 announcing the designation of a substitute for AQUA. It should be noted that strategic decisions affecting the operations of the Agency were postponed until the return of the director.

Finally, the year 2022 has been overshadowed by the war in Ukraine. AQUA has consistently opposed Russia's invasion of this member state of the European Higher Education Area. We express full support for the Ukrainians and, in particular, to the National Quality Assurance Agency for Higher Education (Ukraine), which has tirelessly worked to ensure the quality of higher education in their country during these challenging times.





Among the activities of AQUA in 2022, a few are highlighted below:

- The external evaluation of eleven study programmes and the onset of four new ones; the modification of three study programmes and the onset of two further modifications; the onset of two ex-post programme accreditations and the accreditation of five public calls for research grants.
- The approval by the Steering Committee of a new version of the ex-post programme accreditation guide for the renewal of study programmes.
- The publication of a new edition of the employment integration survey carried out in collaboration with the Ministry of Education and Higher Education.
- The ongoing discussion of the Working Group on Quality in Higher Education in Andorra, with representatives from the Universitat d'Andorra, the Universitat Europaea IMF, the Universitat Carlemany and the Ministry of Education and Higher Education.

This annual report is organized into chapters based on the functions of AQUA:

- 1. Evaluation, certification and accreditation of the quality of education leading to the attainment of official qualifications, teaching staff and research activities.
- 2. Definition **of guidelines**, **criteria and indicators** to assess the quality of higher education in line with European standards.
- 3. **Research for improvement and innovation** of evaluation, certification and accreditation models.
- 4. Advisory services for the Educational Administration, Higher Education Institutions and other entities on matters related to quality in higher education.
- 5. Establishment of **cooperation and collaboration partnerships** with other agencies and entities that have been assigned evaluation, accreditation and certification competencies.
- 6. The report also includes a final chapter on the organization and management of the Agency itself.



1. Quality evaluation, certification and accreditation

1.1. Quality of education

The quality of education is the responsibility of higher education institutions (HEIs), which develop internal quality assessments in coordination with and supported by AQUA, which carries out external evaluations. The external evaluation of **study programmes** is carried out at three times of the life cycle of official degrees:

- Ex-ante programme accreditations.
- Significant programme modifications.
- Ex-post programme accreditations, after ten years, unless otherwise stipulated in the Approval Decree of the ex-ante programme accreditation.

In 2022, external evaluations of the following studies have been carried out (refer to Table 1):

- External evaluations for ex-ante programme accreditations: fifteen evaluations have been carried out: one for the Universitas Europaea IMF, four for the Universitat Carlemany, four for the Universitat d'Andorra and six for the Universitat Humanium. Of this total, four study programmes are pending approval in 2023 (one for the Universitas Europaea, one for the Universitat Carlemany and two for the Universitat d'Andorra).
- External evaluations for programme modifications: five evaluations have been carried out to modify three study programmes of the Universitat d'Andorra and two study programmes of the Universitat Carlemany.
- External evaluations for ex-post programme accreditations: two ex-post programme accreditations have been started, both for the Universitat d'Andorra.

Part of these study programmes have been evaluated and accredited in collaboration with the Quality Assurance Agency of the University System in Catalonia (AQU). This agency is a member of the European Association for Quality Assurance in Higher Education (ENQA) and is registered in the European Quality Assurance Register for Higher Education (EQAR).¹

On the other hand, AQUA has participated in the working groups convened by the Ministry of Education and Higher Education for the **creation of official degrees.** These have been the following:

- Creation of the official degree in Sustainable Urban Space Design (requested by the Universitat Carlemany).
- Creation of the official degree in Social Education (requested by the Universitat Carlemany).
- Creation of the official degree in Political Science (requested by the Universitat Carlemany).
- Creation of the official degree in Data Analytics (requested by the Universitat d'Andorra).
- Creation of the official degree in Physiotherapy (requested by the Universitat Carlemany).
- Creation of official degree in Podiatry (requested by the Universitat Carlemany).

1.2. Quality of teaching staff

Article 22 ("Teaching and Research Staff") of Law 14/2018, of 21 June, on Higher Education², establishes the minimum degree required to teach at the university level. This Article also determines that the university can hire professionals who, without meeting the requirements established in the previous section, have accredited experience in the corresponding area. This hiring, however, requires a prior external evaluation by AQUA and the issuance of an accreditation.

In 2022, no accreditation for teaching and research staff has been processed for any university.

1.3. Quality of research

The external evaluation of the research carried out during this period mainly refers to the participation of AQUA in the selection processes of research grants from public calls. AQUA takes part as an external evaluator, with the explicit role of accrediting that the selection




criteria established for each public call are met and that the principles of objectivity and neutrality are followed in the evaluation of the applications.

In 2022, five public calls of the Ministry of Education and Higher Education of Andorra (MEES) have been accredited (see table 2).

2. Guidelines, criteria and indicators

The quality evaluation criteria are based on the Standards and Guidelines for Quality Assurance in the European Higher Education Area (ESG) and the guidelines of the European Higher Education Area. According to these references, the regulation of official state higher education degrees (Decree of 8-7-2020: Official State Gazette, no. 91, of 15 July 2020) and Decree 63/2021 approving the regulation of the AQUA establish five quality dimensions that must be considered in the evaluation of study programmes:

- Internal quality and continuous improvement.
- Study programmes.
- Academic staff.
- Supporting resources and processes.
- Public information.

In June 2022, the Steering Committee validated the new version of the **Ex-Post Programme Accreditation Guide**. This version includes sections for each criterion that facilitate a better understanding of the evaluation process for all the parties involved.



3. Research for improvement and innovation

With the development of surveys and projects for the improvement and innovation in higher education, AQUA aims to adapt to the new social and employment challenges in a national and international context, seeking rigorous and creative opportunities.

In 2022, AQUA has continued to develop research on employment integration and student outcomes.

3.1. Employment integration research

Since 2017, AQUA and the Ministry of Education and Higher Education (MEES) have been conducting <u>employment integration surveys for individuals holding official degrees in</u> <u>Andorra</u>, with the aim of understanding the employment prospect of individuals who have obtained professional and university degrees from Andorran institutions. The research provides indicators related to employment, the quality of employment and the assessment of the training received by graduates, of interest to universities, the Administration and society.

In 2022, the research projects of the graduating classes of higher education and professional training, who obtained their official degrees in 2017 and 2020, have been completed and presented (see figure 1). The projects are available on the websites of AQUA and the MEES.

3.2. Student outcome surveys

In 2022, the preliminary results of the research project University pathway: access, learning conditions, expectations and outcomes of university studies (2020-2022) were introduced at an internal session to present the main results of the Via Universitària (University Pathway) programme 2020-2022 addressed to the University Quality Vice-Chancellor's.


This survey, led by the Vives Network of Universities with the support of the quality agencies of the Catalan, Valencian, Balearic and Andorran administrations, is the third edition of the international survey on the living conditions of university students and their forms of engagement with their studies. It responds to the need to contribute to the development of systematic studies based on data and with a comparative perspective on the living conditions of students, their study methods, their connection with the university, their cultural habits and economic constraints, as well as their expectations, values and beliefs regarding higher education.



4. Consultancy

One of AQUA's roles is advising the Educational Administration, Education Institutions and other entities on matters related to quality in higher education. The tasks in this sense are very diverse and the most outstanding ones during 2022 are summarized below:

- The **resolution of consultations** on aspects related to study programmes and higher education and their quality.
- The support provided to the Ministry of Education and Higher Education (MEES) in the continuous improvement of the **selection processes for research grants and scholarships**, which includes advising on the drafting of guidelines, selection processes and definition of selection criteria, among other aspects.
- The advisory service provided to the MEES on the drafting of Decree 183/2022, of 4 May 2022, approving the regulation for the authorization of universities and other private higher education institutions in the Andorran higher education system (and its amendment Decree 209/2022, of 11 January 2023), which aims to regulate the establishment of new higher education institutions in Andorra.



5. International relations

5.1. Collaborations, agreements and affiliations

AQUA is part of the following **networks**:

6. Internal management

6.1. Structure

6.1.1. Steering Committee

The governing body of AQUA is the **Steering Committee**, consisting of the president and vice president of the legislative commission of the General Council (Andorran Parliament) responsible for higher education; the minister responsible for higher education; a high-ranking official from the department responsible for higher education; an international expert appointed by the minister responsible for higher education; the rector of the Universitat d'Andorra; a representative rector from other universities in the country; two student representatives from the universities of Andorra, one representing the students of the Universitat d'Andorra and the other representing the students of the other universities of the other universities of Andorra of Commerce, Industry and Services of Andorra or a delegated person and the director of AQUA.

The members of the Steering Committee in 2022 have been:

The Steering Committee holds meetings to approve the activity programme, establish strategic priorities, approve the budget and monitor it and approve the annual report, among other aspects. In 2022, meetings have been scheduled on the following dates: 14th of February 2022, 23rd of February 2022, 21st of April 2022, 16th of June 2022, 25th of July 2022 and 29th of November 2022.

6.1.2. Evaluations Commission

The **Evaluations Commission** has the primary function of issuing the relevant evaluation reports and signing them. It is composed of a minimum of two academics appointed by the Steering Committee, in addition to the AQUA director, who holds the presidency.

The members of the Steering Committee in 2022 have been:

- Dr José Ángel Domínguez, professor of the Department of Mathematics at the University of Salamanca. He left the position for professional reasons in July 2022.
- Dr Carles Solà, emeritus professor of the Department of Accounting and Control at IESE.
- Dr Albert Sangrà, professor of education, professor of the Department of Psychology and Education Studies, academic director of the UNESCO Chair. He started his position during the month of July 2022.
- Dr Marta Fonolleda, director of AQUA.

In 2022, the Evaluations Commission met on the following dates: 26/01/2022, 08/02/2022, 02/03/2022, 11/03/2022, 25/03/2022, 05/05/2022, 19/05/2022, 02/06/2022, 17/06/2022, 30/06/2022, 28/07/2022, 22/09/2022, 05/10/2022, 25/10/2022, 17/11/2022, 25/11/2022 and 22/12/2022.

6.1.3. Board of Appeal

The **Board of Appeal** is responsible for resolving the administrative appeals filed against AQUA resolutions or the Evaluations Commission. It is made up of the high-ranking official of the department responsible for higher education, member of the Steering Committee; the international expert, member of the Steering Committee and the person representing the students of the University of Andorra, member of the Steering Committee; provided they do not have conflicts of interest.



In 2022, the Board of Appeal did not have to manage any appeals.

6.2. Human resources

In 2022, AQUA has had required the following human resources:

Furthermore, AQUA appointed an individual to assume the position of director with a nonexclusive commitment to this role.

In 2022, the human resources of AQUA was affected by two maternity leaves, one involving the Director and the other affecting one of the quality technicians.

6.3. Economic resources

AQUA prepares its annual budget and submits it to the General Council (Andorran Parliament). The Steering Committee of AQUA approves the annual budget, monitoring and closing of accounts.

6.4. Internal quality and continuous improvement

6.4.1. Working Group on the Quality of Higher Education in Andorra

The **Working Group on the Quality of Higher Education in Andorra** has continued to serve as a platform for joint reflection, promotion and action related to the quality processes of higher education. This group consists of representatives from Institutions of Higher Education (HEIs) that offer official degrees (in 2022, the Universitat d'Andorra, Universitat Carlemany and the Universitas Europaea IMF), the Ministry of Education and Higher Education of Andorra and AQUA.

In 2022, the Working Group held three meetings, allowing them to:

- Define the foundations of the Ex-post Programme Accreditation Guide.
- Discuss possible improvements to the External Evaluation Guide of Study Programmes in the field of online education.

The number of meetings of the Working Group was reduced due to the limited human resources at AQUA during the maternity leave periods of the director and the quality technician.

6.4.2. Annual meta-evaluation process

The meta-evaluation serves as the foundation for reflecting on the activities and processes carried out by the Agency to define actions to improve it. In this regard, a meta-evaluation process was carried out in 2022, divided into two distinct parts. On the one hand, an analysis of the level of satisfaction of the experts participating in the evaluations was conducted through surveys. On the other hand, an analysis was performed to identify the critical criteria in the evaluation of study programs.

These two analyses were conducted with the main objective of improving the assessment guidelines for approving study programmes.

The conclusions of the meta-evaluation will be presented in the first quarter of 2023.

6.5. Transparency and communication

The activities carried out by AQUA are planned and approved in the meetings of the Steering Committee, in line with strategic priorities. The activities conducted and the results obtained are documented in the annual activity report, also approved by the Steering Committee and presented to the legislative commission responsible for higher education at the General Council (Andorran Parliament).

The activities of AQUA are regularly published on the Agency's website (<u>www.aqua.ad</u>) in Catalan, Spanish, French and English. The website provides information on the organization of AQUA, external quality assessment guides and processes, public assessment reports, publications and research projects carried out, institutional relations and events beyond our borders in which AQUA participates, among other aspects. Between 64% and 70% of graduates in vocational training from 2017 to 2020 entered the job market while studying or within a month of completing their studies. Furthermore, nearly all students who completed their academic career were employed in Andorra. Among them, 70% of graduates from 2017 have permanent contracts and 54% of those who obtained their degree six months ago have also secured permanent positions. Among the recently graduated, 2% claim to be self-employed, an option not reported four years ago. [...]

Favourable government endorsement for the revision of AQUA's fees

The Government has issued a favourable stance on the legislative proposal to modify the fees of the Quality Assurance Agency for Higher Education of Andorra (AQUA). This initiative aims to establish new fees and update current amounts, taking into consideration the expanded functions of the institution. This information was reported yesterday through the Official Gazette of the General Council (Andorran Parliament). In this way, as highlighted by the Executive, the decree approving the regulation for the authorization of private universities and other higher education institutions was promoted in May of this year.
